**Beyond 60 days of Certificate Date\***, returns will not be accepted by CA.

\* Certificate Date is the date of issuance and can be found on the upper right portion of the License Certificate.

CA requires a completed letter of destruction for all returns.

ABC SOFTWARE shall use the information obtained from any such audit solely to determine Licensee's compliance or non-compliance and to remedy any non-compliance. If it is determined that Licensee is in non-compliance, Reseller agrees to bill Licensee, at CA's discretion, for the reasonable expenses of the audit.
