Product Delivery

CA's normal processing time on orders is 1-2 business days. Licenses plus information on downloading the media are delivered via email.

Renewals

Renewals must be purchased within 60 days of the renewal date of the license. Upgrade licenses must be purchased if beyond the 60 day renewal period. If renewing early please make sure to reference the customer's existing order ID#/OL# on your PO.
