Key Products

Monarch is a Windows-based, report mining software from Datawatch that extracts data from existing reports created within any information system. It then facilitates easy data analysis, graphing and data exporting to other applications

Monarch Professional –mines data from existing text-based, PDF or XPS reports. It also lets you access and analyze data from database files, spreadsheets, ODBC sources, delimited text, and HTML files.

Monarch Data Pump –is a server-based data distribution, ETL (Extraction, Transformation, Loading) and application integration solution. It automatically accesses and transforms unstructured data sources, such as report files and PDF files, into live, customized data in various formats, including Excel.

Monarch Data Pump Professional –all of the report and data mining capabilities of Monarch Data Pump Standard plus it offers remote web administration. Web Services interface. It also has the ability to tightly integrate with Microsoft SQL Server 2005 Integration Services.

Maintenance/Support

Maintenance is optional and but always recommended. Maintenance is only available on licensing. Retail box product does not offer the maintenance. Maintenance must be purchased on a one to one basis with licenses.

Media

Hard copy media is provided free for all new licenses purchases.

There are no special authorizations required to resell this product.

Ordering Requirements

Datawatch licensing minimum purchase is 10 licenses. Customers must purchase retail box for any order under qty 10. Adding licenses to an existing license agreement has a minimum purchase of qty 5. Please be sure to include the following information when placing your order with us:
