## Renewals

VLA/ENPVLA Maintenance customers must renew their Maintenance prior to its expiration to take advantage of the "Renewal" Maintenance price. Once renewed, the new Maintenance expiration date will be one or two years from the original Maintenance renewal expiration date (depending on the renewal SKU ordered).

Once the Maintenance expires, an "Expired" Maintenance price is available for VLA/ENPVLA customers who want to reinstate their expired Maintenance contract.

The new Maintenance expiration date will be set to one or two years from the date of the expired maintenance order (based on the maintenance SKU's ordered).

If a customer's Maintenance expires and FileMaker announces the availability of an upgrade, the customer is no longer eligible for the Expired Maintenance price. The customer must purchase the product upgrade or (if they don't qualify for the upgrade version) new licenses.
