Maintenance/Support

Crystal Reports Server Standard and Enterprise Support – Standard and Enterprise Support must be purchased with new server Licenses. Enterprise Support includes 24 x 7 Technical Support and software updates for one year from the date of purchase.

Media

All media is provided via free electronic download. When an order is processed, the customer will receive a license confirmation email containing a download link and login credentials for the media.

Authorization Requirements

There are no specific authorizations needed for Crystal Reports and Crystal Server. Authorized Reseller Program (ARP) is available for SAP HANA and Sybase IQ products.

Ordering Requirements

There are no minimums for SAP orders. To assure prompt processing of your purchase, please be sure to include the following information when placing your order with us:

1. PO number
2. End-user agency/organization name
3. End-user shipping street address, city, state and zip code
4. End-user contact name - first and last name required
5. End-user contact phone number
6. End-user contact email address (email domain must match business name)

Product Delivery

SAP normal processing time on orders is 2-3 business days. Licenses are delivered via email. The delivery must go directly to the end user, however, resellers are copied in on the license e-mail. The license confirmation email contains a download link for the media.

Renewals

Send renewal quote requests to the SAP team box with end user information.

Pricing Programs

Government/Education: Gov-Ed skus are reserved for: State, Local and Federal Government agencies; K-12; Higher Educational institutions; Non-Profit agencies. Proof of eligibility is required.

If purchasing products for a government end user on Click2License, please note your government pricing will not be visible to you. Your government discounted pricing will apply when your order is processed.

Important Notes

SAP does not support downgrades. SAP has a month end order cut off at 6pm eastern the weekday before calendar month end. Please have your orders in at least 4 hours prior to this cut off to ensure processing.

Returns Overview

SAP return policy is 30 days from the date of order with an offsetting/replacement order.

Returns are granted for licenses purchased within the past 30 calendar days at the vendor's discretion.

The vendor has to approve the RMA before further action can be taken.

If SAP approves the return, a completed letter of destruction is required.

The LOD form is at the bottom of this document and must be filled out by the end user and returned back to our desk.

We will request this from you once the vendor has approved the return.
