# CA ARCserve Springboard SPIFs: Official Program Rules



### PROMOTIONAL TIMEFRAME: April 1, 2011 as now extended through September 30, 2011

Sales of eligible CA ARCserve® products must be accepted by CA between Friday, April 1, 2011 and Friday, September 30, 2011. All claims MUST be submitted on-line or postmarked no later than 60 days after the actual date of sale. The last date any claim will be accepted is Tuesday, November 29, 2011 (for sales made on September 30, 2011). Sales of qualifying SKUs made prior to April 1, 2011 or after September 30, 2011, do not qualify.

#### **ELIGIBLE PARTICIPANTS**

Eligible participants are sales representatives, 21 years of age or older, who reside in and are employed by a CA Registered, Silver, Gold or Platinum Reseller Partner in the fifty United States, District of Columbia or Canada. Distributors and their sales representatives, employees and funded heads of CA, or their promotional agencies, and their respective families are not eligible for this promotion. To claim and receive SPIFs, participants are required to be registered on the CA Partner Rewards Center (www.capartnerrewardscenter.com). Participants are subject to their employer's policies regarding contest eligibility, participation and prize acceptance.

### **ELIGIBLE PRODUCT SALES**

Eligible product sales include select CA ARCserve Backup r15, CA ARCserve D2D r15, CA ARCserve Replication r15 and CA ARCserve High Availability r15 (all for Windows) new product and competitive upgrade SKUs with 1 or 3 years enterprise maintenance, which are sold to end users via CA Open License Program (OLP) only, during the promotional timeframe. #### **CLAIM SUBMISSION: Online Submission**

Eligible individuals must complete and submit an online Claim via the CA Partner Rewards Center (PRC) site, which can be accessed at www.capartnerrewardscenter.com. As part of the online claim process, you will be required to provide certain proof-of-sale information (including: a copy of the CA OLP License Certificate or sales invoice to the end user (with pricing blacked out), as well as end-user competitive product information (name of competitive product) when applicable. Follow the instructions online. Group claims may need to be filed manually – see your CA Representative for details. Claims must be filed/received NO LATER THAN 60 DAYS after the actual sale date (or for claims with multiple sales, you must file within 60 days after the earliest date of sale). Likewise, if an organization/group has already claimed/received for a specific sale, then the same sale cannot be claimed by an individual. ## **CLAIM VERIFICATION**

Verification of all claims will take approximately 7-10 days from date of submission. All SPIF claims will be verified against multiple CA reports. Sales will be verified against CA's licensing sales database and the date reflected in CA's reporting will be considered the official "sale date" of the order. These reports will also determine the official quantity of the order, regardless of quantities shown on invoices provided by claimant. Sales may also be verified against CA's returned merchandise report. If the eligible product sold has been returned without another qualifying product sale replacing it, the claim will NOT be paid. Competitive product information will be reviewed for validity and CA reserves the right to request additional information for verification.

#### **CLAIMS DEADLINE**

Eligible claims must be submitted and received NO LATER THAN 60 DAYS from the actual date of sale (according to CA sales reports). The last date claims will be accepted is November 29, 2011 (for sales made on September 30, 2011).

# **SPIF PAYMENT**

SPIFs will be paid in the form of cash funds, loaded onto a reloadable ARCserve.com Visa® Prepaid Card, which is obtained by participant after their first claim is made, approved and funded (approximately 2-4 weeks). Additional SPIF payments (or if you already have an ARCserve.com Visa Prepaid Card) for newly approved SPIFs will be loaded onto the card approximately every 2-4 weeks after claim approval. All taxes are the sole responsibility of each individual or company. 1099 Misc. Income Forms will be issued to all qualified individuals (US residents only), as required by law. All SPIF payments listed are in US dollars.
