Webtrends Analytics 8, Each version ranges in page views from 1 million page views into the billions (except Advanced marketing and Commerce which begin at "up to 10 million). Requests for 250 million and above, including renewals, refer direct to Webtrends for approval.

<u>Standard Package</u> – Basic requirements, functionality and reporting functions. 100 essential analytics reports. Uses: intranets, companies that do not require extensive functionality.

<u>Marketing Package</u> - Additional 45 reports. Geographical distributions, marketing searches. Targets: online marketing managers, those requiring expanded functionality

<u>Advanced Marketing Package</u> - Custom reporting. Targets: power business users, a lot of online marketing, those with unique marketing or reporting needs. (Renewal Only)

<u>Commerce Package</u> - 35 additional merchandising and product reports. For on-line retail and transactional web sites. (Renewal Only)

<u>Add-ons</u> – purchased separately for increased functionality: Smartview, marketing reports, commerce reports, custom reporting, advanced smartview

<u>Page View Add-ons</u> - Additional page views can be purchased for all packages. The price for the add-on is the same no matter how many page views the end-user currently has.
